It is to inform that, the Govt in the reference 6th cited referred the matter to the District Collector, Visakhapatnam and directed to give Instructions to Registration department to curtail further transactions on the plots which were irregularly allotted in the Sy.No. 174, 175 and 161 of Madhurawada (V).

In this regard, after examining the enquiry report furnished by the Joint Registrar, District Co-Op Office, Visakhapatnam; the lands covered in **Sy.No. 174, 175 and 161 of Madhurawada (V) notified in Prohibited Properties u/s 22 (A) (1) (a) of AP Registration Act and published in District Gazette vide Gazette Issue No. 9/2016 Dt: 28.1.2016.**

The Government of Andhra Pradesh have brought the Registration (AP Amendment) Act, 2007 into force w.e.f 20-07-2007 inserting section 22-A of the Act, by notification, through G.O.Ms.No.863 Revenue (Reg.I) Department Dt.20.06.2007 (Act 19 of 2007).

In exercise of the powers conferred by Government Notification of the Act, 19 of 2007 and as per the Minutes of the High Level Committee (Constituted vide G.O.Ms.No.1182, Revenue (Registration-I) Department, Dt: 18.11.2009), the draft List of Prohibited properties U/s 22-(A) (1) (a) and the List of Immovable properties owned by the State or Central Govt U/s 22-(A) (1) (b) situated in **Visakhapatnam Revenue Division covered by 9 Mandals including Visakhapatnam-(R) Mandal** were first published vide Vishakhapatnam District Gazette No.75, Dt:13.8.2014. Further, the published lists are placed in the District Web site i.e., <http://visakhapatnam.nic.in> and also published at all Tahsildars' offices concerned, Village Chawadis and Gram Panchayats/Municipal offices concerned for information of the public and inviting objections, if any, within a time of 30 days from the date of publication in the Gazette.
